- C. The Executive Director will present a proposal to replace San Juan Excursions at suite 101 Spring Street Landing.

Action Item:

- **A.** The Commission will consider authorizing Resolution #20-012 which would authorize the acceptance of the Washington State Community Economic Revitalization Board (CERB) grant and loan.
- **B.** The Commission will consider authorizing Victoria Compton, Executive Director of the San Juan County Economic Development Council's (EDC) request for funds be incorporated into the proposed 2020/2021 budget. The EDC is requesting \$12,500 for continuing work in the community as well as \$6,500 towards the Business Recovery Coordinator position.
- **C.** The Commission will consider whether to approve the authorization of unbudgeted construction of self-work / contractor work bays at Shipyard Cove. The estimated costs would be less than or equal to \$40,000 with an estimated payback period less than or equal to 3 years.
