As of November 1<sup>st</sup>, the Port of Friday Harbor will take over the operation of the Jensen's Boatyard. The yard will close for a period of time to reorganize and open again at the first of the year. Upon reopening, Port staff will operate travel lift, block vessels, and wash vessel hulls. All other vessel work will be provided by vendors and individual boat owners.

This questionnaire will help the Port work with local vendors to rent appropriate workspaces, find out how what services you provide, and how many employees you will have working with you.

Included with the questionnaire is a map of the boatyard highlighting spaces that will be available for use on a monthly basis. Rental of space is not required to have full access to work on vessels in the yard.
