AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Port of Friday Harbor from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll – gross wages, leave balances and accruals, benefit deductions
- Accounts receivables – billings, adjustments, and collections for the Marina
- Self-insurance for unemployment

INFORMATION ABOUT THE PORT

The Port of Friday Harbor fosters economic activity by developing and maintaining harbors and terminals to promote tourism in San Juan County. The Port provides and charges rental, tariffs and other fees on docks, wharves and similar harbor facilities including associated storage and traffic landing facilities for waterborne commerce. In addition, the Port provides freight and passenger terminals and transfer for other modes of transportation including air and motor vehicles.

An elected, three-member Board of Commissioners governs the Port. Board Members serve staggered, six-year terms. The Board appoints a Port Director to oversee the Port's daily operations as well as its 19 full-time employees. For fiscal year 2018, the Port operated on approximately \$3.9 million in annual revenue.
